- Electronic bids must be submitted to the Office of Dipayal Silgadhi Municipality, Doti through PPMO website www.bolpatra.gov.np. on or before 12:00 Noon on 2077/11/23. Bids received after this deadline will be rejected.
 The bids will be opened in the presence of Dillar to the presence of Dillar
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00pm on 2077/11/23 at the Office of Dipayal Silgadhi Municipality, Doti. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned below, which shall be valid for 30 days beyond the validity period of the bid.
