Dipayal Silgadhi Municipality Office *has received a grant* from GoN towards the cost of construction of Covered Hall at Silgadhi -06, Doti and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Covered Hall, Silgadhi -06, Doti (Contract No: NCB/DSNP/06/080/081). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Office of Dipayal Silgadhi Municipal Executive invites electronic bids from eligible bidders for the Construction of Covered Hall work consists RCC Frame Structure work, Steel Truss & Prefab Building including complete finishing work. Under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Nrs. 19,896,132.00 [in word: Rupees One Crore Ninety-Eight Lakh Ninety-Six Thousand One Hundred Thirty-Two Only]**
- Minimum Work experience of similar size and nature: **Nrs. 10,186,819.00 [Rupees One Crore One Lakh Eighty-Six Thousand Eight Hundred Nineteen Only]**
- **For Further qualifications Bid Document Should be Referred**

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit Nrs. 5000 the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at Dipayal Silgadhi Municipality Office Silgadhi, Doti at 25th March, 2024 A.D. (12th Chaitra, 2080 B.S.) at 2:00 PM.
7. Electronic bids must be submitted to the office Dipayal Silgadhi Municipality Office Silgadhi, Doti through PPMO website www.bolpatra.gov.np on or before 12:00 PM on 3rd April, 2024 A.D. (21st Chaitra, 2080 B.S.). Bids received after this deadline will be rejected.
8. The bid will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 3rd April, 2024 A.D. (21st Chaitra, 2080 B.S.) at the office of Dipayal Silgadhi Municipality Office Silgadhi, Doti. Bids must be valid for a period of 90 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs. 708,810/- (Rupees Seven Lakh Eight Thousand Eight Hundred Ten Only)**, which shall be valid for 30 days beyond the validity period of the bid. If Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Deposit account No.: 4100100303000004 of Office of Dipayal Silgadhi Municipality, Doti at Rastriya Banijya Bank, Silgadhi and submit the receipt of the deposited amount of cash along the bid or scanned PDF copy in case of e-submission
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.

Such amendment and correction shall be published in the national daily newspaper, notice board of the Dipayal Silgadhi Municipality Office, Silgadhi, Doti.
