4. Sealed bids must be submitted to the Office of Dipayal Silgadhi Municipal Executive, Doti . before 2076/1/9 12:00 noon
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00pm on 2076/1/9 at the Office Office of Dipayal Silgadhi Municipal Executive, Doti. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security, amounting to a minimum of as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Deposit account No.: Ga-3036 of Office of Dipayal Silgadhi Municipal Executive, Doti at Rastriya Banijya Bank, Silgadhi and submit the receipt of the deposited amount of cash along the bid.
6. The Quotation will be awarded to the eligible firm who offer highest amount for the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
