4. Pre-bid meeting shall be held at **Office of Dipayal Silgadhi Municipality, Doti** at **12:00 Noon 2076/1/7**.
5. Electronic bids must be submitted to the **Office of Dipayal Silgadhi Municipality, Doti** through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before **12:00 Noon** on **2076/1/16**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00pm** on **2076/1/16** at the **Office of Dipayal Silgadhi Municipality, Doti**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Deposit account No.: **4100303003036** of *Office of Dipayal Silgadhi Municipality, Doti* at *Rastriya Banijya Bank, Silgadi* and submit the receipt of the deposited amount of cash along the bid or scanned PDF copy in case of e-submission.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
