A complete set of Bidding Documents may be purchased from the Office of Dipayal Silgadhi Municipal Executive, Doti by eligible Bidders on the submission of a written application, along with the attested copy of company/firm registration certificates all valid for F/Y 075/076. Tax Clearance certificate (latest) and upon payment of a non-refundable fee as mentioned below till 2075/11/14
4. Sealed bids must be submitted to the Office of Dipayal Silgadhi Municipal Executive, Doti.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00pm on 2075/11/15 at the Office of Dipayal Silgadhi Municipal Executive, Doti. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum of as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Deposit account No.: Ga-3036 of Office of Dipayal Silgadhi Municipal Executive, Doti at Rastriya Banijya Bank, Silgadhi and submit the receipt of the deposited amount of cash along the bid.
6. Suppliers should have authorized dealer or suppliers for supply of bus.
7. Bidder for Supply of rafting boats should submit Sealed Quotation of technical and financial proposal for rafting accessories and training.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
