- The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00pm** on **2078/6/17** at the **Office of Dipayal Silgadhi Municipality, Doti**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Deposit account No.: 4100100303000004 of *Office of Dipayal Silgadhi Municipality, Doti* at *Rastriya Banijya Bank, Silgadi* and submit the receipt of the deposited amount of cash along the bid or scanned PDF copy in case of e-submission.
